Instructions:

- 1. Divers and Dive Supervisors are eligible for Accreditation from the Commercial Diving Association (Singapore) CDA(S) if they meet any one of the following requirements:
 - A. Have successfully completed a course of instruction and assessment from a Learning Service Provider recognised by the Ministry of Manpower (MOM) to meet the requirements of the Singapore Commercial Diving Competency Standards for Inland/Inshore Commercial Diving, or
 - B. Have successfully completed an Assessment Only Pathway (AOP) Program for experienced divers, from a Learning Service Provider recognised by the Ministry of Manpower (MOM), to meet the requirements of the Singapore Commercial Diving Competency Standards for Inland/Inshore Commercial Diving, **or**
 - C. Currently in possession of a recognised equivalent* commercial diving training qualification from outside Singapore (*for example, commercial diving qualifications recognised by IMCA or HSE UK), subject to approval of the CDA(S) Executive Committee
- 2. The application and renewal fees are **SGD\$100**, for accreditation valid for **5 years**.
- 3. NOTE: This Accreditation does not amount to Membership to CDA(S) those who wish to join CDA(S) as full Association members may apply separately.
